## Zakat

- Zakat is one of the five pillars of Islam
- It is prescribed for the well off to distribute a small portion of their accumulated wealth on those who are less fortunate
- Just like prayer and fasting, it is mandatory on those who meet the minimum criteria

## **Quranic Advice**

وَمَا ءَاتَيْتُم مِّن رِّبًا لِيَرْبُوا فِي أَمْولِ ٱلنَّاسِ فَلَا يَرْبُوا عِندَ ٱللَّهِ اللَّهِ النَّاسِ فَلَا يَرْبُوا عِندَ ٱللَّهِ اللَّهِ فَأُولَئِكَ هُمُ ٱلْمُضْعِفُونَ وَجْهَ ٱللَّهِ فَأُولَئِكَ هُمُ ٱلْمُضْعِفُونَ

## Chanda ≠ Zakat

- It is a common misconception that Jama'at chanda is substitute for Zakat
- Hazrat Masih Mau'das said

"O ye people who consider themselves among my Jama'at, heaven will only count you in my Jama'at when you truly strive in the path of Taqwa. So observe your five daily prayers with such fear and concentration as if you actually see Allah. Complete your fasts only for the sake of Allah with sincerity. Whoever of you is capable to pay Zakat should do so. And whoever can perform the Hajj, and there is no obstacle in his way, he should perform it". (Kishti Nuh)



### Chanda ≠ Zakat

Hazrat Khalifatul Masih I<sup>ra</sup> said,

"Regardless of all the collections, our Jama'at has through Chandajat, it does not behoove a movement, which is the movement of the Promised Messiahas, not to give proper attention to the principles which form the basis of Islam. Just as paying Chanda does not relieve us from the obligation to pray, fast and perform the Hajj, in the same way it does not make any difference in the payment of Zakat". (Report Sadr Anjuman Ahmadiyya 1911-1912)

#### Hazrat Khalifatul Masih IV<sup>rh</sup> said

"Zakat is a Quranic injunction...It must be paid whenever the conditions which make it binding are fulfilled".



#### How is Zakat Calculated?

- Zakat is assessed on <u>savings</u> that are in your possession for one year
- If you earn a million dollars in a year and spend all of it then you don't owe any Zakat on it
- Cash, cash-equivalents, stocks, precious metals, jewelry, and other liquid assets are all counted for this purpose



### Nisab

- Nisab is the minimum threshold of saving above which Zakat becomes mandatory
- It is tied to price of silver. Nisab is 52.5 Tola (614.25 g) of silver
- At today's rate (Dec 2014) this is \$324 which means almost all of us in the US probably owe some Zakat



#### Rate of Zakat

- For ordinary savings such as cash, cashequivalents, etc. that were described above which are held longer than a year the rate is 2.5%
- For other types of assets such as crops, livestock, mineral deposits the rates are different but for the sake of brevity those are not described here.

- Who do you pay the Zakat that is due?
  - To Secretary Finance of your Jama'at
- Is Zakat due on your house?
  - No
- What about household items?
  - Zakat is not calculated on personal items of daily use such as furniture, clothes, household items, cars, etc. regardless of their value

- What if you have loaned money to someone?
  - Zakat is not due on the money that is loaned
- How about stocks in retirement funds?
  - Zakat is not due unless an investment is realized. Zakat on funds in retirements accounts such as 401(k), 403(b), IRA, etc. will only be calculated once the money is withdrawn and there is some savings in that year

- What about Jewelry?
  - You probably don't own any precious jewelry but your wife may. Regarding jewelry Hazrat Masih Mau'das said,

"Jewelry that is regularly used is exempt from Zakat. Jewelry that is mostly stored and occasionally worn, one should pay Zakat on it. The jewelry that is worn and occasionally given to the poor to wear is exempt from Zakat according to some. The jewelry that is worn and is not given to others to wear, it is preferred to give zakat on it because it is used for one's self; that is how it is done in our household. Every year we give Zakat on our jewelry. There is no difference of opinion that that one should pay Zakat on jewelry that is kept like cash". (Majmua Fatawa Al-Hakm 17 Nov, 1905)

- What can Zakat money be spent on?
  - Eight uses for Zakat are defined in Surah Taubah

إِنَّمَا ٱلصَّدَقُتُ لِلْفُقَرَآءِ وَٱلْمَسْكِينِ وَٱلْعَمِلِينَ عَلَيْهَا وَٱلْمُؤَلَّفَةِ فَلَّوبُهُمْ وَفِي سَبِيلِ ٱللَّهِ وَٱبْنِ فَلْوبُهُمْ وَفِي سَبِيلِ ٱللَّهِ وَٱبْنِ اللَّهِ عَلِيمٌ مَكِيمٌ السَّبِيلِ اللَّهِ وَابْنِ اللَّهِ عَلِيمٌ حَكِيمٌ اللَّهِ عَلِيمٌ حَكِيمٌ اللَّهُ عَلِيمٌ حَكِيمٌ
